

We stood at the Stratford Hotel looking out the window with tears in our eyes wondering what to do when the Board threatened to pull our insurance during the eighteen-day strike.

Phil was a teacher advocate like no other! He would go into negotiations with his briefcase bearing a sign which read, "My heart is in public schools and so are my children" forcing the chief negotiator for the Board to continually look at that sign.

Under Phil's leadership the AEA negotiated the first wall-to-wall contract which included ALL staff.

After retirement, Phil became the President of IRTA. He <u>never</u> stopped advocating for teachers.

If a union is needed in heaven, Phil Robbins is "already on it!"
